

END USER LICENSE AGREEMENT (EULA)

This End User License Agreement (“Agreement”) is entered into between **Braxton-Grant Technologies, Inc.** (“Licensor”) and (“Licensee”), which may be a corporate entity or a government agency. If Licensee is part of a larger organization, such as a multinational corporation or government department, this license applies only to the named Licensee entity and does not extend to its parent organization, affiliates, subsidiaries, or other government agencies or departments.

“**Software**” means **both** (i) the ODIN-I solution provided by **Licensor**, including assets stored within Elastic such as visualizations, dashboards, indices, templates, pipelines, and mappings, as well as (ii) software developed by **third-party providers** (including but not limited to **Elasticsearch B.V.** (“Elastic”)) upon which Licensor’s software is built, all of which are licensed under a Subscription. This includes all updates and new releases made generally available by Licensor or the third-party provider during the applicable Subscription Term.

Licensor acknowledges and agrees that its rights to distribute, license, and provide access to the Software are subject to the terms and conditions imposed by the providers of any underlying software components included within the Software.

By installing, accessing, or using the Software, **Licensee agrees to be bound by the terms of this Agreement, and Licensor agrees that its rights and obligations under this Agreement are also subject to the applicable license agreements governing the third-party software incorporated into the Software.**

1. LICENSE GRANT

Licensor grants Licensee a **non-exclusive, worldwide, non-sublicensable, non-transferable, and limited** right to use, copy, distribute, make available, and prepare derivative works of the Software (“**Software**”) solely for internal operations. Licensee may install and use the Software only within its own entity. If Licensee is:

- A corporate entity (e.g., a company or nonprofit), the license applies only to the named entity and does not extend to its parent company, sister companies, or affiliates.
- A government agency (e.g., a federal, state, or local agency), the license applies only to the specific agency, office, or department that acquired the license and does not extend to other government entities.

Licensee may not:

- provide Software to third parties as a hosted or managed service, where the service provides users with access to any substantial set of the features or functionality of the Software.
- move, change, disable, or circumvent the license key functionality in the software, and may not remove or obscure any functionality in the software that is protected by the license key.
- alter, remove, or obscure any licensing, copyright, or other notices of the licensor in the software. Any use of the licensor’s trademarks is subject to applicable law.

2. PATENTS

Licensor grants Licensee a license, under any patent claims the Licensor can license, or becomes able to license, to make, have made, use, sell, offer for sale, import and have imported the software, in each case subject to the limitations and conditions in this license. This license does not cover any patent claims that you cause to be infringed by modifications or additions to the software. If Licensee makes any written claim that the Software infringes or contributes to infringement of any patent, Licensee's patent license for the software granted under these terms ends immediately. If Licensee makes such a claim, Licensee's patent license ends immediately.

3. NO OTHER RIGHTS

These terms do not imply any licenses other than those expressly granted in these terms.

4. OWNERSHIP

The Software is **licensed, not sold**. Licensor retains all ownership rights, including copyrights, trademarks, and any intellectual property rights. Licensee acknowledges that no ownership interest is transferred under this Agreement.

5. RESTRICTIONS

Licensee shall **not**:

- Modify, reverse engineer, decompile, or disassemble the Software.
- Copy, distribute, sublicense, or make the Software available to any third party, including any other division, subsidiary, affiliate, or related government agency.
- Use the Software in any manner inconsistent with its intended purpose or in violation of applicable laws.

6. SUPPORT & UPDATES

Licensor may provide updates, patches, or technical support at its sole discretion under a separate support agreement. Any updates provided shall also be subject to this Agreement.

7. DISCLAIMER OF WARRANTIES

The Software is provided **"AS IS"** without warranties of any kind, express or implied, including but not limited to warranties of merchantability or fitness for a particular purpose.

8. LIMITATION OF LIABILITY

As far as the law allows, Software comes as is, without any warranty or condition, and Licensor will not be liable to Licensee for any damages arising out of these terms or the use or nature of the software, under any kind of legal claim, including any indirect, incidental, consequential, or special damages arising from the use or inability to use the Software, even if advised of the possibility of such damages.

9. TERM & TERMINATION

This Agreement remains in effect until terminated. Licensor may terminate this Agreement immediately if Licensee breaches any terms. Upon termination, Licensee must cease using the Software and destroy all copies.

10. GENERAL PROVISIONS

- **Scope Limitation:** This Agreement applies only to the named Licensee entity and does not extend to any related entity, whether corporate (parent companies, affiliates, or subsidiaries) or governmental (other agencies, offices, or departments).
- **Governing Law:** This Agreement shall be governed by the laws of the state of Maryland, USA.
- **Entire Agreement:** This Agreement constitutes the entire understanding between the parties regarding the Software.
- **Severability:** If any provision is found to be invalid, the remaining provisions shall remain in full force and effect.

By installing or using the Software, Licensee acknowledges and agrees to these terms.
